# TECHNICAL MANUAL SR701RT Rev. B







1. Carefully review the placement of component parts within the carry bag by removing the wheels. NOTE: Each component has its place within the carry bag.



2. Remove the above components from bag laying them out as illustrated. NOTE: Make sure you have placed the Stanchions correctly. This is accomplished by making sure the groove atop the Stanchions face inward. Also the tube assemblies will be explained later.



3. Slide the stainless steel Axle through the 3/4" hole located at the bottom of the 7 hole Stanchion to the outer most groove located on the Axle. Secure Axle in place by tightening knob located at bottom of Stanchion. Repeat procedure for the opposite Stanchion.



4. Stanchion assembly has been assembled correctly with grooves atop Stanchion facing inward as illustrated above.



5. Slide 26" Kickstand into 3/4" hole located directly above Axle as illustrated. NOTE: There is a groove located at either end of the Kickstand, this will be engaged by a stainless steel ball plunger located within the Stanchion.



6. Install Wheels and insert Rue pins to secure. To install Rue Pins push into hole at end of Axle and they will snap secure. To lock Rue Pins in place activate optional manual lock. To remove Rue Pins unlock and lift end of pin which has slight bend and pull.(NOTE: Rue Pins are stored in pouch.)



7. SR701RT wheel assembly is now assembled and ready to receive the assembled Support Tube Rail Assemblies.

8. There are two Support Tube Rail Assemblies, one for each clamp on the SR701RT stanchions. A rail assembly is made up of 5 parts: 2 Support Tubes (37 inches each 1-1/2 diameter), 2 Handle Subassemblies (the part with the nylon handle inserted in a tube) and 1 (one) Connecting Tube (20 inches 1-1/4 diameter).





Assemble the Support Tube Rails by inserting the short Connecting Tube into one of the 1-1/2 inch Support Tubes (Handle Sub Assembly should already be inserted into the other end) until the stainless steel snap button pops into the hole in the 1-1/2 inch tubing.



9. Take another 1-1/2 " Support Tube and insert it over the remaining part of the Connecting Tube until the stainless steel snap button pops in the hole in the 1-1/2" tube. Repeat the above steps to complete the other Support Rail Assembly.


10. You should now have two Support Rails completed as picture above. They are ready to install into the stanchion clamps.



11. Prior to placing the Support Rail into the Clamp Assembly atop the Stanchion, slide the top of the Clamp back (as pictured on the left). Once the Support Rails have been placed into the bottom of the Clamp, place the top of the Clamp over the Support Rail (pictured at right). Note: the larger stainless steel snap buttons on the Support Tube Rail Assemblies should point out to the side of the stanchions.



12. There is a smaller snap button that should be used to position the Support Rail on the Stanchion Clamp. The small snap button should be visible and lined up with the slot on the top part of the Clamp. See picture above.





15. Begin assembly of Kickstand by sliding Kickstand collar onto 1/2 of Kickstand assembly until it engages stainless steel snap button as illustrated. Repeat this procedure with remaining half of Kickstand.




16. Kickstand assembly is now ready to be mounted to Support Rails. Note: Position of Kickstand Collar should be set to the outer button position (largest distance between clamps).



17. Loosen Clamps on Kickstand Assembly and slide onto Support Rails. Note: Keep even and position Kickstand Clamp over first Snap Button until it shows through position hole on side of clamp. See picture 18 below. Once in position tighten Clamp.If you wish to elevate/fold up Kickstand loosen clamps (Note: Clamps must be loose enough to allow posi-lock to disengage to allow Kickstand to be raised into transport position.)




18. Correct position of Kickstand Clamp over first snap button.




20. Begin Stretcher Cross Member installation by loosening side knobs so the Cross Member can slide on to the Support Rails. Place on end of the Support Rail and tighten side Knob until the Cross Member is secure. Repeat for the other end.



21. Once the Kickstand and Cross Members are installed the Stanchion Support Tubes, used to position the stanchion, can be move from their bottom position to a top position. In the higher position they are out of the way and can be used to hang equipment if desired.







### **LIMITED WARRANTY**

This warranty extends for the lifetime of Charlie's Horse as long as the original retail purchaser owns it. This warranty extends to the original retail purchaser only and commences on the date of original retail purchase. Accordingly, this warranty is not transferable to any subsequent purchasers.

Any part of Charlie's Horse manufactured or supplied by North Coast Outfitters Ltd. and found in the reasonable judgment of North Coast Outfitters Ltd. to be detective in material or workmanship will be repaired or replaced by North Coast without charge for parts or labor.

Charlie's Horse including any defective part must be returned to North Coast Outfitters Ltd. The owner will pay for the expense of returning Charlie's Horse to North Coast Outfitters, Ltd. and the expense of returning it back to the owner after repair or replacement. North Coast Outfitters Ltd. responsibility in respect to warranty claims is limited to making the required repairs or replacements within 60 days, and no claim of breach of warranty shall be cause for cancellation or rescission of the contract of sale of any Charlie's Horse.

Proof of purchase will be required by North Coast Outfitters Ltd. to substantiate any warranty claim. North Coast Outfitters Ltd must perform all warranty work.

If Charlie's Horse is used commercially for such purposes as rental or other income-producing activities, then this warranty is limited to one (I) year from the date of original retail purchase. Military use is considered commercial use.
